BOARD OF DIRECTORS MEETING MINUTES June 7, 2024

Leah reported that Dawn Heffernan relayed that she has not seen any return to the area of the invasives which were cleared last year.

Agenda:

- Brandon Lagoy Membership application. Attendees voted unanimously to make Brandon Lagoy a member.
- Request to distribute meeting minutes. Tom Wartenberg has asked that minutes be distributed. Because of the small number of attendees this was tabled till the next meeting.
- Beach permit. Dawn asked for confirmation that no permit is required from Foothills. Charlie will double check that if it needs to be renewed annually.
- Golf Tournament. Attendees discussed whether there will be a Golf Tournament this year, to honor at the very least. Mike M will discuss with Rob Maloni. Attendees also discussed whether Yardworks is currently caring for the greens and whether spraying has increased.

Several items were raised that needed broader discussion so we tabled till the July meeting:

- The Water Board has asked HAC to pay for barn water access. For the current year, the cost would be \$900, likely to be reduced to \$350 in the future. Dawn suggested that we might pay the dues, but not the assessment for 2024.
- Mike noted that it is time to raise the Barn rent.
- Mike also noted that we should revisit the commitment to paying for Barn wifi.
